The undersigned hereby agrees to foster the following animal(s) (hereinafter "Pet" or "Pets") currently in the Adoption Program of Paw Prints Animal Rescue, Inc. ("Paw Prints"):

In connection with this arrangement, I acknowledge the following (*please initial each section*):

___ I will allow Foster Coordinator, or another duly authorized representative of Paw Prints, to inspect the animal care area of my residence prior to and during the foster of Pet(s).

___ Except as noted below, I accept temporary possession of the Pet(s) to be harbored at my own expense and risk: _____

___ I will be responsible for providing the following care for Pet(s):

- Proper food and water
- Daily exercise, as needed
- Training (e.g., house-training dogs and puppies), socialization (e.g., holding cats and kittens) and play time
- Adequate shelter (indoor only for cats and kittens)
- Administration of any prescribed medical care
- Other: _____

___ I understand that Pet(s) shall be fostered temporarily at my place of residence and that I will return Pet(s) to Paw Prints at its request.

___ If at any time during the foster care of Pet(s) I feel that any non-routine veterinary care is required, I will contact Foster Coordinator immediately so that arrangements may be made with a veterinarian approved by Paw Prints. In the case of an emergency during non-business hours, I will immediately contact the Foster Coordinator for instructions.

___ If, at any time, I encounter any problem in the foster care of Pet(s), I will contact Foster Coordinator and/or Paw Prints immediately.

___ I understand that I am free to solicit prospective homes for Pet(s) but will not initiate any adoption proceedings for Pet(s) and will refer all interested parties to Paw Prints for adoption.

____ I will be responsible for the safe transportation of Pet(s) to and from Foster Coordinator, another authorized representative of Paw Prints or a veterinarian approved by Paw Prints in connection with any routine or non-routine veterinary treatment of Pet(s) while in my care. I understand that dogs and puppies must be transported on leashes and cats and kittens must be transported in carriers.

____ At the time Pet(s) has received proper veterinary care, socialization and training, I will deliver Pet(s), and any records relating to Pet(s) in my possession, to such adoption events as directed by Foster Coordinator. I understand that dogs and puppies should be bathed, brushed and have their nails trimmed before adoption events and cats and kittens should be brushed/combed and have their nails trimmed. I also understand that my presence at such adoption events is not mandatory but highly desirable as it facilitates in the most optimal adoption of Pet(s).

____ I understand that the rights to Pet(s) and the final disposition of Pet(s) remains with Paw Prints.

____ I hereby acknowledge that I am an independent contractor and not an agent of Paw Prints.

____ I understand that Paw Prints and its authorized agents and volunteers assume no liability for damages caused by Pet(s) while in my custody and that Paw Prints and its authorized agents and volunteers cannot guarantee the temperament or other personal characteristics of Pet(s).

____ If, for any reason, Pet(s) is not surrendered to Paw Prints for adoption or otherwise, I will be responsible for all expenses incurred by Paw Prints related to Pet(s) and will reimburse Paw Prints for same immediately upon request.
